A core group of CAF External Feedback Actors (the evaluators) is selected by the National organizer. On this note, Development Manager, Aila

Särmälä (CAF National Correspondent), ensures that CAF self-assessment and CAF External Feedback sets a benchmark for future improvements in the public sector.

The CAF Procedure of External Feedback adds value to the use of CAF and to its users. Public sector organizations will want to see the results of all their efforts and they require feedback about their efforts. This CAF External Feedback by peers and experts will help organizations take the next steps on their quality management journey towards making their efforts visible both internally and externally.

Implementation of Quality Management Systems in the Public Administration in Slovenia



Based on the priorities of governmental Strategy of Public Administration Development, the Ministry of Public Administration intensified its activities regarding the implementation of Quality Management Systems in public administrations in 2017. To speed up the process, new employees joined the Quality Department within the Development Office.

In the field of implementation of the CAF model in public administrations, 13 out of 14 ministries of the Slovenian Government decided to implement their first self-assessment of the organization, among them, the Governmental Secretariat-General was also present. Training sessions and regular meetings of quality management representatives were carried out, followed by self-assessment activities. By autumn 2017, five ministries prepared action plans to improve the functioning of organizations, the remaining ones are expected to deliver their action plans by the end of the year. The majority of organizations involved found CAF very useful, working groups detected many areas for improvements and the communication amongst employees was also improved. Besides, teamwork in the organizations has increased, and the quality awareness was improved among all employees.

Following the great results mentioned above, in Slovenia a new cycle has commenced, inviting other governmental bodies to join the CAF community, which is expected to grow to twelve new CAF users in 2018, not to mention another 30 regular CAF users planning to execute self-assessment procedures in 2018.

Moving onto the practicality of CAF External Feedback Procedure, a pilot project was launched in spring 2017 and it successfully terminated in September. Six applicants - Administrative Units (AU Grosuplje, AU Kočevje, AU Krško, AU Slovenska Bistrica, AU Vrhnika and AU Zagorje ob Savi) and sixteen External Feedback Actors participated in the project. The results showed that the participating applicants are well experienced in performing self-assessments.

On average, they showed to be able to possess the required criteria for proper organization. Furthermore, the applicants showed high quality commitment of management, focus on customers and social responsibility. The project ended during the 61st EOQ Congress in October, where all the participating applicants and External Feedback Actors were awarded their diplomas for cooperating in the project. In the near future, a second pilot project of CAF EFP will be launched, implementing the lessons learned in the first pilot project. Later in 2018, a regular CAF EFP is planned.

The use of CAF in the Greek Public Administration

Within the Greek Public Administration, a 3-year action plan 2018-2021, which includes CAF promotion and implementation in specific sectors of the Greek public administration, was submitted to the Minister. Furthermore, a new organizational unit at the Ministry of Administrative Reconstruction was established. Such unit, is responsible for quality, CAF implementation and PEF.

For 2018, training workshops in all the regions of the Greek Government for the CAF implementation are being planned. Such workshops will cover CAF/ECU promotion and implementation to public services such as Hospitals and social welfare organisations.

Additionally, the design of a new platform to promote CAF implementation and knowledge is taking place. At the legislative level, a proposal to introduce PEF in the public administration, as well as training activities of experts to the use of PEF is being developed.
