**PUBLIC HEALTH ACT
(CAP. 465)**

**Travel Ban (Extension to All Countries) (Amendment No. 6)
Order, 2021**

IN EXERCISE of the powers conferred by article 27(c) of the Public Health Act, the Superintendent of Public Health has made the following order:-

Citation and
commencement.
S.L. 465. 26.

1. (1) The title of this order is the Travel Ban (Extension to All Countries) (Amendment No. 6) Order, 2021 and this order shall be read and construed as one with the Travel Ban (Extension to All Countries) Order, hereinafter referred to as "the principal order".

(2) This order shall come into force on 23rd September 2021.

Amends article
2 of the
principal order.

2. Article 2 of the principal order shall be amended as follows:

(a) the second proviso thereof shall be substituted by the following new proviso:

"Provided further that persons may travel from Malta to the countries listed in this proviso and from the countries listed in this proviso to Malta as long as, upon their arrival in Malta, they are in possession of a vaccination certificate:

(b) in the sixth proviso thereof, the words "the second proviso." shall be substituted by the words "the second proviso:" and immediately thereafter there shall be added the following new proviso:

"Provided that each person who resides in the same residence with a person who is subjected to quarantine pursuant to this Order must adhere to the same period of quarantine."
