### **Superintendence of Public Health**

#### **Structure, Functions and Responsibilities**

The Superintendence of Public Health, under the headship of the Superintendent of Public Health, assists and advises the Ministry on the formulation of regulations and standards and ensures that regulations and standards which are promulgated by Government are implemented by both state and private service providers. It is the responsibility of the Superintendence of Public Health to monitor standards, license and inspect health care service facilities and, where necessary, enforce regulations. The Superintendence of Public Health is responsible for ensuring that all public health legislation is upheld.

The Superintendent of Public Health gives direction to the directorates falling within the Superintendence of Public Health to ensure that the regulatory functions emanating from law are properly discharged.

The directorates/units falling within the Superintendence of Public Health are:

- Directorate for Health Care Standards
- Directorate for Health Promotion and Disease Prevention
- Directorate for Environmental Health

#### **Health Care Professions Regulatory Councils**

Although the Health Care Professions Regulatory Councils are legally independent and autonomous, they are administrative accountable to the Superintendence of Public Health. They encompass the following:
